

# MASTER CLASS: new directions in working with domestic violence

Domestic violence is a serious public health concern, associated with health and social costs, and the cause of well documented emotional harm to children.

Although psychological approaches to working with male perpetrators is well established, it has been a challenge to evidence the impact of these approaches. Similarly, strenuous attempts by Local Authorities to establish safety plans and robust risk management approaches for women and children are sometimes thwarted in the context of enmeshed and complex family and organisational dynamics.

This study day is delivered by experts in the field, and aims to bring the interested practitioner up to date with the current evidence base in relation to outcomes and theoretical models. The day focuses on new approaches to an interpersonal and holistic understanding of the challenge of domestic violence, with a focus on interventions.

The aim is to engage practitioners in new ways of thinking - sometimes challenging existing assumptions - in order to encourage innovation and renewed enthusiasm for work in this area.
